- Your fingerprints and photograph will be taken at the Immigration Office at the time the application is submitted.
- This form must be completed in English using blue or black ink only.
- The content on your application may be taken without an interview with you. Therefore, please ensure that you submit all relevant documents, certified copies and supporting documents.
- It was false the credibility of your application if you supply false information on this document.
